- Waterfield Midstream LLC- signed by MLT Land Services LLC located on CR C3301. Driveway Permit.
- Delek Logistics Operating LLC located on CR B2200. Driveway Permit
- Jonathon Bynum/Culberson Construction Inc. located on CR C3100 being 36" in diameter, made of Poly and used for the transmission of water.
- Clearwater-Gesch Operating Inc. located on CR B3701 being 20" in diameter, made of steel for 16" poly and shall be used for the transmission of water.
- Medallion Pipeline Co., LLC has two permits. Located on CR CC3200 and CR C2201 both being 10" in diameter, made of steel and used for the transmission of oil.
